Dear Mayor Jim Strickland,

I, Jane Doe for safety reasons, am writing this letter in regards to imminent safety concerns for me, but especially for my child. In addition, there is a public safety concern involving the Memphis Police Department. First, I will discuss the imminent safety concern, which is due to George West, Jr., who is also known by Main Main. George (Main Main) is going to either kill my child and me or me in front of my child. However, after I expound on other details, his threat may end up being secondary to others.

My child and I have witnessed, experienced, and seen George's (Main-Main) razor-thin temperament, which quickly morphs into uncontrollable violence. From George (Main Main) cutting my wrist because he wanted to see how sharp the knife was to him pointing a gun at a man's head and pulling the trigger to try to kill that man in front of my child and me, George (Main Main) has shown us what he is capable of doing. However, I will never call or make any additional police reports on George (Main Main) nor will I ever go to another court proceeding on anything that he does because it was pointless and simply added to the trauma. In addition, I do not trust police officers especially the Memphis Police Department to address any of these matters without ill intentions.

However, it is imperative that I speak louder for the safety of my child in other forums because my child does not deserve to live in fear: sending this letter is one way; the news site www.notmychild.life is another way; and literally going out and protesting and calling by names anyone that places my child's or my life in danger including those who choose to ignore these serious concerns on our lives.

I will refrain from going into graphic details of all of the abuse spanning over 2 decades, as all of that information will be made available on the news site mentioned above. However, I will validate my claims of George's (Main Main) attempts into trying to kill me, please see the enclosed print out (labeled as Exhibit A) of a text conversation of my child and George (Main Main). As you will note, George (Main Main) is admitting to being physically abusive towards me, trying to kill another person and me on several occasions of which my child has had to beg him not to kill me, trying to attack my child, lying/perjuring himself (referring to George) in court, amongst other things. Please note: George (Main Main) is the text respondent in gray and my child is the respondent in green. The communication started from presumably George's (Main Main) number of

901-708-0341 of which my child responded on February 17, 2020 with communication continuing until April 26, 2020. However, the last few text messages are not included, as it was George (Main Main) trying to manipulate my child and trying make my child communicate a message to me. Also, George (Main Main) contacted my family member in July of 2020 in order to further harass me.

In addition to the text messages, please listen to the audio located at the top page with a direct link, as <https://notmychild.life/why-do-this/> (it represents Exhibit B). It will contain a series of audio that will further allow you to see the type of character that my child and I dealing with. Without a doubt, this should further prove that my child and I are in danger.

Now, I arrived at this nightmare from a series of previous abuses. However, the Memphis Police Department has had the worst impact on my life, which is the reasons why I do not trust police officers. First, Officer John Pasley of Memphis Police Department murdered my father in an execution style murder per NAACP, but this Department and the Shelby County District Attorney's Office covered up the officer's crime despite there being three (3) independent witnesses that gave clear statements that contradicted the police report and verified that Officer Pasley in fact murdered my dad. However, corruption prevailed as these "authorities" are given the power to dismiss crimes as severe as murder in order to look out for their own, as this is a common theme. The Memphis Police Department's crime resulted in my siblings and me being left in the sole hands of a "mother", who was a monster. My father's murder caused a devastating affect on his children's lives including being subjected to physical and sexual abuse at the hands of a step-father, family friends, cousins, uncles, and neighbors.

The second worst impact that the Memphis Police Department had on my life was when a gang of officers decided to conspire to hide my rape and physical abuse. I was raped on March 8, 2015 by George (Main-Main), which I told Sgt. Richard Borden (IBM # of 0044) and Sgt. Kevin Covington (IBM # 2470). In addition, George (Main Main) brutally beat and attempted to kill me on March 23, 2015, but I tried running away from George (Main Main). However, George (Main Main) chased me down and cornered me, so I had to save my life. There was no other option. After going over the reports, I was able to see how these officers' created narratives that never occurred to create a story that never existed, but it appears that the knots and bruises on my face at least was able to tell some of the story that these officers wanted to cover up. Why would these officers do this? Without a doubt, it was Sgt. Richard Borden (0044), who started this entire narrative, because he seemed annoyed at me for saying the word "raped". I saw the flinch and irritation in Sgt. Borden's eyes when I said that word. I will say this firmly Sgt. Borden punished me for saying the word "raped" and these officers all just fell in line to support the lie. The list of the gang of officers' names, who conspired to cover up my rape and abuse, are the following:

1. **Sgt. Richard Borden**, who is a white male, with an IBM # of 0044
2. **Sgt. Barnabus Bradley**, who is a black male, with an IBM # of 2305
3. **Sgt. Kevin Covington**, who is a black male, with an IBM # of 2470

4. **Officer Brian Redick**, who is a black male, with an IBM # of 10619
5. **Officer R. Finnie**, who is a black male, with an IBM # of 6869
6. **Officer Margaret Walker**, who is a black female, with an IBM # of 2467
7. **Lt. J. Bell** with an IBM # of 0690

I was raped and beaten. This statement is not an allegation; it is a fact! My experience showed me that these officers were corrupt. In my opinion, there is something eerily disturbing for Sgt. Borden (0044) to be so annoyed at me for saying that I was raped. After reviewing all of the officer's IBM files, it is apparent that the Memphis Police Department continues to maintain a culture of corruption, which is a public safety concern. In order to prove my findings, I will show you a glimpse of accusations made by other citizens and their fellow officers regarding the officers' mentioned above. These accusations are crimes which include threatening to shoot a child, going inside a female citizen's pants and lying on her with an independent witness verifying the officer lied, stealing, abuse of spouses, choking a child, and so on.

In Sgt. Barnabus Bradley's file (IBM # 2305), there is a plethora of allegations and policy violations from the Memphis Police Department of crimes that this officer has committed (labeled Exhibit C). Despite the absent of criminal charges being filed, these are still considered crimes that the average citizen would have been arrested and charged. It is unbelievable that officers get the privilege of simply getting away with it. In August 2000, Sgt Bradley's former wife, Tonya Bradley, accused him of pushing her while there were 2 witnesses inside to gain entrance into a home that Sgt. Bradley was not residing at to confront Mrs. Bradley's guests. On March 29, 2013, Sgt. Bradley was accused of choking and threatening to shoot a child, named Dantirus Harris. There were 2 additional witnesses the collaborated this incident: named Cartravious Harris and Demarqueline Townsend (labeled Exhibit D). On May 27, 2014, Sgt. Bradley took a report from Darrien Johnson, who is the son of his long time girlfriend by the name of Sgt. Frankie Lanton. Mr. Johnson made a statement in order to press charges against his ex-girlfriend. Sgt. Bradley secured a warrant for an alleged aggravated assault against the son's ex-girlfriend, who is named D' Audrey Byrd. Ms. Byrd was forced to turn herself into the police, but it appears based on reports that she was surprised by the charges, as she stated that the incident never occurred nor was she ever contacted. In addition, Ms. Byrd made it clear that this incident placed a veil of distrust in her for police officers, as Sgt. Bradley was bias in securing this warrant. MPD concluded that Sgt. Bradley violated DR 109 Impartial Attitude and DR 120 Neglect of Duty (labeled Exhibit E). On another occasion with a different wife, who is named C. Davis-Bradley, Sgt. B. Bradley was accused of calling her bitches, whores, and being aggressive while he had their young daughter on his hip. This officer's file is riddled with violence and aggression towards women, so I will stop here, as to not overwhelm this letter with Sgt. Bradley's criminal behavior. Yet, this officer was still allowed to remain in the Domestic Violence Unit of all places when he helped to conspire to cover up George's (Main Main) physically abuse of me.

In Sgt. Kevin Covington's file (2470), he has been accused of several violent attacks on citizens. In 2002, two (2) victims by the names of Ernst Reed and John Brazley, who

stated that Sgt. Kevin punched Mr. Brazley in the face while Mr. Brazley was laying on the ground. In addition, Mr. Reed was admitted into the hospital (labeled Exhibit F). In July of 1998, Elbert Smith accused a gang of officers including Sgt. Kevin Covington of brutally beating him, which resulted in Mr. Smith sustaining fractured ribs, blood in his urine (hematuria), lumber spur, lacerations to the face, neck and upper arms (labeled Exhibit J). Mr. Smith alleged that a gang of officers including Officer Redick rushed his car and started beating him. In Officer Margaret Walker's file (IBM #2467), this officer was accused of stealing records from the Memphis Police Department to conceal information of her sister, who was a police recruit named Gloria Bolton-Grice (labeled Exhibit G). Officer Walker hid the details of my rape that I recounted to her, as we spoke for over one (1) hour about all the details of my rape. Officer Walker has shown a pattern of dishonesty, as stealing is by nature a dishonest crime. Yet, Officer Walker is given the privilege of stealing from the Department with no criminal charges. In Lt. J Bell's file (IBM #0690), he was accused of covering up Officer Beck's crime of stealing drugs off of a suspect despite 2 other officers, who are named Officer Faircloth and Officer Forbert, reporting the crime to Lt. Bell (labeled Exhibit H). Conspiring to conceal a crime is within itself a crime and one that is dishonest, but Lt. Bell tried to protect his own. This crime shows that Lt. Bell is dishonest.

Lastly, I will explore some of the information in Officer Brian Redick's file (IBM #10619) (labeled Exhibit I). On July 24, 2011, Officer Redick's brother, who was named Larry Redick, was involved in a barricade incident at 2670 Rhea in Memphis. Larry Redick was accused of shooting out of the house. However, there were bystanders, who were also the brother and a five (5) year old nephew of Officer Redick, standing in front of the house. However, the other officers disregarded the bystanders' safety and responded by firing into the house, which prompted Officer Redick to push past his fellow officers (labeled Exhibit K). This behavior of the Memphis Police Department to disregard the safety of people and children is not uncommon, which is another reason why there is so much distrust of officers. These officers should have retreated and not jeopardized the safety of the bystanders by shooting towards the house. If this were a citizen, we would be charged with endangering the lives of that child and that man. However, officers get to shoot first even though their training teaches them otherwise. In 2007, Officer Redick claimed that he had to protect himself from Lee Caples, so Officer Redick shot and killed Lee Caples (labeled Exhibit L). I am not unreasonable; if this was truly a self-defense matter, I understand, but I find Officer Redick's behavior hypocritical, as I tried to protect myself from someone who actually assaulted, chased me down, and tried to kill me. Yet, Officer Redick and the gang of officers got to decide if I was raped and if I deserved to defend myself. On December 17, 2013, Officer Redick pulled Sharon Tuggle over on 576 South Perkins Road in front of Kroger's. Officer Redick was accused of cursing Ms. Tuggle out in front of her children and other pediatricians including other children. In addition, Ms. Tuggle made a statement that Officer Redick actually went inside her pants, which the Department did not address. While being investigated, Officer Redick denied that he did these things, but an independent witness, who is named Jeffrey Morgan, made a statement, which verified Ms. Tuggle's allegations (labeled Exhibit M). Thus, based on witnesses', Officer Redick is a liar, which is a crime to do so in an investigation against yourself, but of course no

criminal were filed.

For the sake of time, I refrained from expounding upon all of the criminal aspects of each allegation and “policy” violation in their files, which are mainly really crimes of these officers. However, this history of these officers show a clear and convincing argument that these officers have a pattern of being dishonest, which happened to me when they conspired to hide my rape and abuse.

This system is corrupted: court, prosecutors, and police officers. It is designed to strip our voice away. It is designed for citizen’s to distrust officers and vice versa. It is designed for the District Attorney’s Office to see us all as criminals and cover up for their buddies in the police department and get rewarded based on prosecution not actual truth or even justice. All of this is designed this way on purpose: To keep all the peasants “fighting” amongst each other. Yes, prosecutors and officers are within our class, as all of us at the bottom are the peasants including them.

I am not saying that we need to abolish the police department, as this would be irrational. In addition, the police officers come from our own neighborhood, so it is important to maintain a local police department, as their families stay here as well. Thus, they will have a higher probability of being more invested in making our community better. Also, I am not making a claim that all judges, officers, or persecutors are corrupt because this would be an unreasonable statement. However, retraining and abolishing the violent and manipulative culture of the police department and District Attorney’s Office should be the goal, but this is a dream, as the vicious machine will forge ahead taking from it what it wants without penalty unless we, the people, say enough.

I consider current tactics of the Memphis Police Department, as terroristic style policing with citizens suffering from a sort of Stockholm syndrome, as we are forced to call a department that suppress us while officers cover up their own crimes or label it as “policy”. Certain communities fear and distrust the police department so much that they would rather deal with safety consequences of being silent than ever call the police. This is why I will never call the police on George (Main Main) ever again, as this department has taught me repeatedly not to trust their actions.

Now, I have a disclaimer to make just in case anyone including these Departments and officers attempt to do something to me: I have no intentions to harm others or myself. If I end up dead, it won’t be by my hands. If I come up missing, it won’t be because I ran away. If charges or police stops mysteriously starts happening to me, it won’t be because I have broken any laws. It will be because they are trying to silence me.

Some of you may choose to ignore this letter including those that I have carbon copied, but I won’t stop speaking out. Matter of fact, this letter will be posted and the names of every person and entity that I sent this too shall follow with a response. My child’s safety is not optional; it is mandatory. No one will make my child feel like she is worthless.

Based on Tenn. Code Annotated § 37-1-401 and § 37-1-403, anyone that is made aware

of abuse to any child under the age of 18 is mandated to report the child abuse of any child who has suffered or sustained any wound, injury, disability or physical or mental condition.

Although my actual identity is easy to ascertain, I labeled this communication as Jane Doe for a mere second of safety. If you would like more details from me, please mail me at the address above or contact help@notmychild.com and it will be provided.
